**ORDER:**

1. The “AVR & SVR College of Engineering & Technology, Ayyaluru(V), Nandyal (M), Kurnool Dist” was given Temporary affiliation for running Degree courses during the academic year 2009-10 vide Procs.(1) read above.
2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2010-11 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2010-11 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted an Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee for recommendations for granting Temporary affiliation for the academic year 2010-11. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2010-11 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before January, 2010.

1. Governing body meetings should be conducted regularly.
2. 80 P4 computers are to be added.
3. Reprographic facility to be provided in the library.
4. Digital signal processing, microwave & optical wave and electrical measurements lab are to be strengthened with equipment.
5. Faculty to student ratio in EEE, Civil Engg & IT departments should be improved.
6. At least 50% of faculty appointments should be ratified by the University.
7. Principal appointment is to be ratified by the University.
8. Faculty Cadre ratio should be maintained at 1:2:6 (Professor, Associate Professor, Assistant Professor)
