ORDER:

1. The “SVR Engineering College (formerly AVR & SVR College of Engineering & Technology), Ayyaluru (V), Nandyal (M). Kurnool Dist.” was given Temporary affiliation for running Degree courses during the academic year 2018-19 vide Procs.(1) read above.
2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2019-20 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Permanent affiliation from the academic year 2019-20 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Permanent Affiliation from the academic year 2019-20 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report.

1. Built up area should be made available as per AICTE norms
2. Student to Teacher ratio should be maintained as per AICTE norms
3. Faculty cadre ratio is to be maintained as per AICTE norms
4. Associate Professors should be appointed
5. The college should apply for NBA, NAAC status
6. Sports facilities should be provided and Physical director should be appointed immediately.
7. VLSI lab should be established
8. CAD/CAM lab should be established
9. Most of the softwares are open source and legal software should be procured
10. Majority of new equipments should be procured for ECE lab. CSE labs are only two and are used by both UG & PG
11. Library facilities like e-resources and standard journals are to be maintained

3. Under the circumstances as stated above, the Vice-Chancellor is pleased to Grant **Permanent Affiliation** to "SVR Engineering College (formerly AVR & SVR College of Engineering & Technology), Ayyaluru (V), Nandyal (M), Kurnool Dist." sponsored by "Little Flower Educational Society, Flat No.102, Sai Pragathi Residency, Street No.2, Ashok Nagar, Hyderabad" to offer the following courses with the intake shown against each for a period of **03 (Three) years from the Academic Year 2019-2020** as detailed below:

The Permanent/Temporary affiliation shall be subject to the following conditions:

1. The management shall follow the norms of AICTE and the rules of the affiliation of JNT University Anantapur in all aspects.
2. The management shall follow the Academic Regulations and examination schedule of JNT University Anantapur.
3. Anti-ragging measures to be taken strictly in accordance with UGC regulations on curbing the menace of ragging in Higher Educational Institutions, 2009 (F.1-16/2007 (CPP-II))
4. Regular meetings of College Academic Committee and Governing Body shall be conducted.
5. The College shall invariably upload the mandatory disclosure on their website.
